# RESOLUTION AUTHORIZING THE EXECUTION OF AN AGREEMENT WITH THE PENNSYLVANIA DEPARTMENT OF TRANSPORTATION FOR THE T-633 LOWER GEORGES VALLEY ROAD BRIDGE REPLACEMENT OVER POTTER RUN

**WHEREAS,** Potter Township recognizes the need to replace the T-633 Lower Georges Valley Road bridge over Potter Run; and

**WHEREAS,** Potter Township desires to approve the Standard Bridge Reimbursement Agreement for the costs incurred during the Preliminary Engineering, Final Design, Utility Relocation, Right-of-way Acquisition, and Construction phases.

**NOW, THEREFORE, BE IT RESOLVED,** that the Potter Township Board of Supervisors does hereby authorize the Board Chair to sign, on behalf of the Potter Township Board of Supervisors, the Reimbursement Agreement between Potter Township and the Pennsylvania Department of Transportation and have the same delivered to the Commonwealth of Pennsylvania.

**RESOLVED BY** the Township of Potter, Centre County, Pennsylvania, that

WHEREAS, the Board of Supervisors of Potter Township supports the grant application made to The Happy Valley Adventure Bureau (HVAB), in partnership with the Centre County Board of Commissioners, for the 2022-2023 Tourism Grant Program. The application is for recreational use, specifically to provide safety features and field renovations on each of the two baseball fields at the Potter Athletic Complex. The sports complex is 29 acres and located at 150 Summer Lane, Centre Hall, Pennsylvania, and will attract tournaments and league use, and

**WHEREAS**, the Board of Supervisors of Potter Township recognizes the twenty-five (25) percent match requirement for the 2022-2023 Tourism Grant program, and has secured the matching funds

**NOW, THEREFORE, BE IT RESOLVED**, that if Potter Township is awarded a grant by The Happy Valley Adventure Bureau and Centre County Board of Commissioners, the Board of Supervisors of Potter Township agrees to accept the grant award, and may enter into an agreement with The Happy Valley Adventure Bureau and Centre County Board of Commissioners for the above referenced project.
