Local citizens are interested in ensuring that any potential local alignment selection that may impact Sleepy Creek gives proper consideration to the sensitive, hydrologic and environmental characteristics of this small stream. Mr. Foust made a motion to recommend approval of the proposed name, Sleepy Creek, for the tributary. Mr. Dutrow seconded the motion. **Vote in favor was unanimous. 4-0.**
