APPROVAL OF MEETING MINUTES

SIDEWALK ORDINANCE

The Commission continued its discussion on the draft provisions for a proposed Sidewalk Ordinance. The draft will be finalized by Ms. Hamsher and will be provided to the Commission for a final review.

REGULATING CHICKENS in the RESIDENTIAL DISTRICT

The Commission preliminarily reviewed a comparison of municipal regulations for regulating chickens in residential areas. The Chair asked the members to review the comparison, which will be discussed at the Commission's November 12th meeting.

NEW BUSINESS

Andrew Dutrow Minor 2-Lot Subdivision

The Commission reviewed that Minor Lot Subdivision located on Manor Road. Ms. Albright of Albright Land Surveys explained that Lot 1 will include the existing house. Lot 2 will be a 4/10 of an acre vacant lot. Lots are served by public water and public sewer. She noted that the Centre County Planning and Community Development Office asked for proof of a driveway permit to meet the requirements for the plan.

Following the review, the Planning Commission did not have any concerns. No action needed.

OTHER BUSINESS

Ms. Foust noted that a question was raised on whether a solar farm has been proposed in the Industrial District. The Commission were not aware of any proposals on the matter.

ADJOURNMENT

There being no further business before the Planning Commission, Ms. Foust moved to adjourn the meeting and was seconded by Ms. Hamsher. The motion was approved unanimously. Chair Troyan adjourned the meeting at 8:50 PM.
